What is this product?

Type
This product is a share of an investment company qualifying as an

ALE submitted to part II of Luxembourg alternative investment fund (AIF) submitted to part II of Luxembourg investment fund law.

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

The sub-fund aims to invest in diversified asset classes in order to generate stable returns and ensure a preservation of the capital invested on a long-term basis.

Specifically, the sub-fund will invest directly and indirectly in debt securities of any type (government and corporate), equities and equity related securities, undertakings for collective investment (UCIs) including alternative investment funds, structured products and money market instruments.

For hedging and for investment purposes, the sub-fund may use all types of financial derivative instruments such as options on equities and equity related securities.

The sub-fund will try to generate positive returns through an active management of its portfolio and by identifying underlying assets with a sustainable risk profile.



What are the risks and what could I get in return?

Risk indicator

What happens if SAVILE THEMATIC OPPORTUNITIES is unable to pay out?

In the worst case, however, you could lose your entire investment.

What are the costs?
